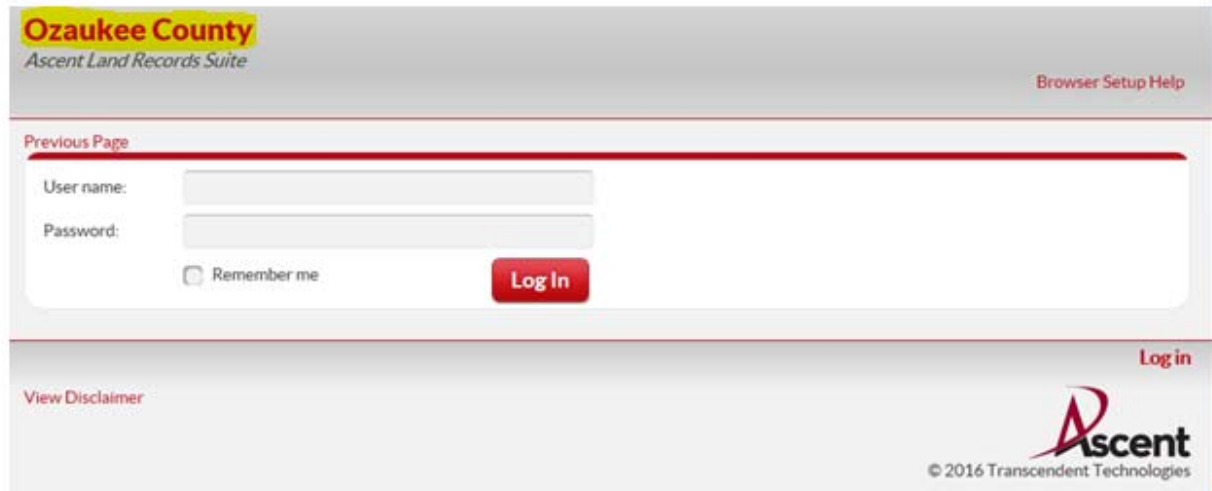

Click on link: www.ascent.co.ozaukee.wi.us/landrecords to open the Ozaukee County Ascent Land Records Suite.

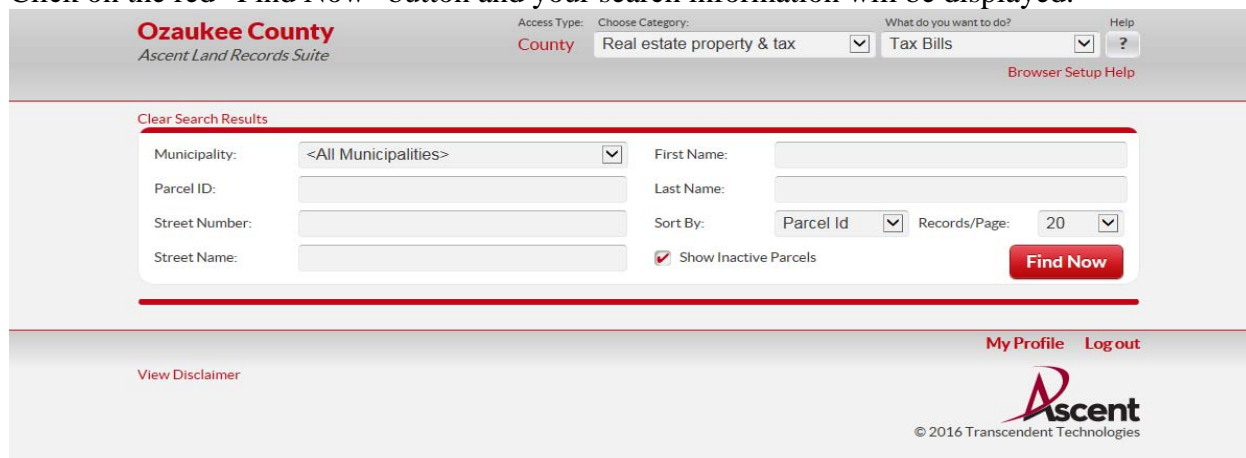
Click on the red “Ozaukee County” to get to the search screen (no Log-in required).



Search by Parcel ID (no dashes or dots) **or** Street Number and Street Name (do not use N,S,E, or W or Street, Road, Ave, etc. (example: 100 N Main Street - only enter **100 and Main**). You do not need to Select a Municipality if you are not sure if it is a City, Village or Town.

First Name and Last Name fields are grayed out and are only used internally by the Ozaukee County.

Click on the red “Find Now” button and your search information will be displayed.



Click the red parcel number search result on the left side of the screen to open a new screen with the details of your parcel.

For all other municipalities, Ozaukee County collects current taxes after February 1st. Payments can also be made on the Ozaukee County website for delinquent taxes.

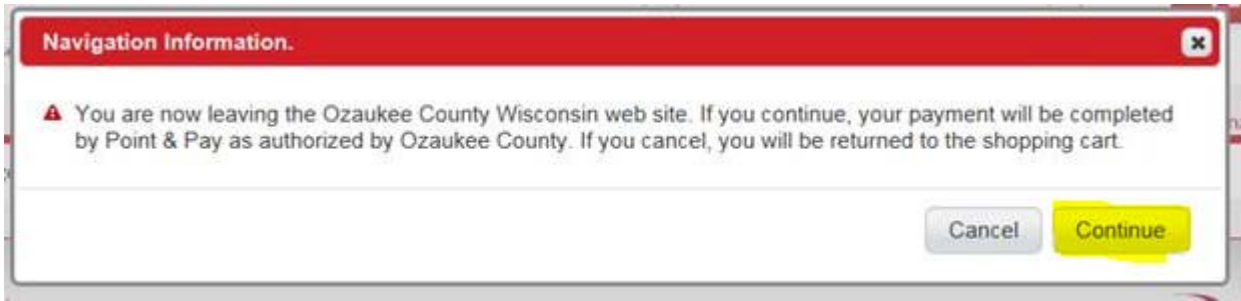

The Navigation Information window will pop up stating that you are leaving the Ozaukee County website and redirecting you to Point and Pay. Click on “Continue”. This will open up another web browser page. If the new webpage does not open, it is because your Pop Up Blocker has blocked this task.



Point and Pay Payment Provider

On the Select Payment screen you can choose to pay by Credit Card, Debit Card or by Electronic Check. Enter your name and address as it would appear on your credit card or bank account. Phone number and email address are optional, however if a problem arises Ozaukee County can then call or email you. Under Payment Information, the Payment Method defaults to Credit or Debit Card. If you wish to pay via electronic check, click on the drop down arrow and change to electronic check. This will change the fields below to Routing Number, Account Number and Account Type. Click “Continue” after required information is entered.

Point and Pay is our third party payment system. They charge an additional fee of 2.39% for credit and debit card transactions and \$1.50 for electronic checks.

Point and Pay Customer Service number is 1-888-891-6064.

Review and Submit screen will appear next. Confirm your payment and the fee charges. Confirmation and Receipt screen appears next. You can print off your receipt at this point or if you put in an email address, a receipt will be emailed to you.
