## Copies of Tax Receipt & Tax Bill Instructions

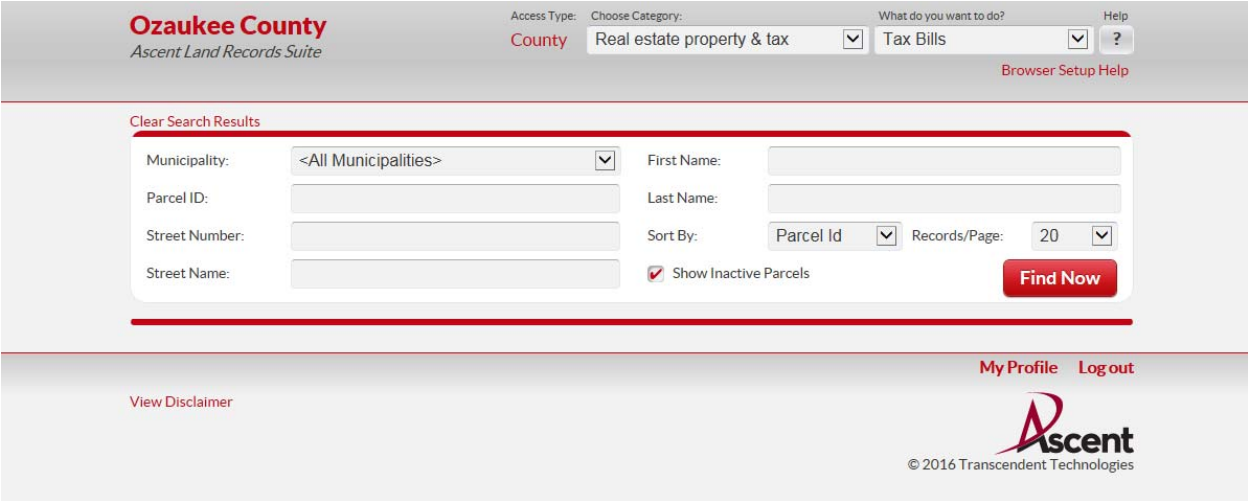
Click on link: [www.ascent.co.ozaukee.wi.us/landrecords](http://www.ascent.co.ozaukee.wi.us/landrecords) to open the Ozaukee County Ascent Land Records Suite.

You will then click on the red “Ozaukee County” to get your search screen.

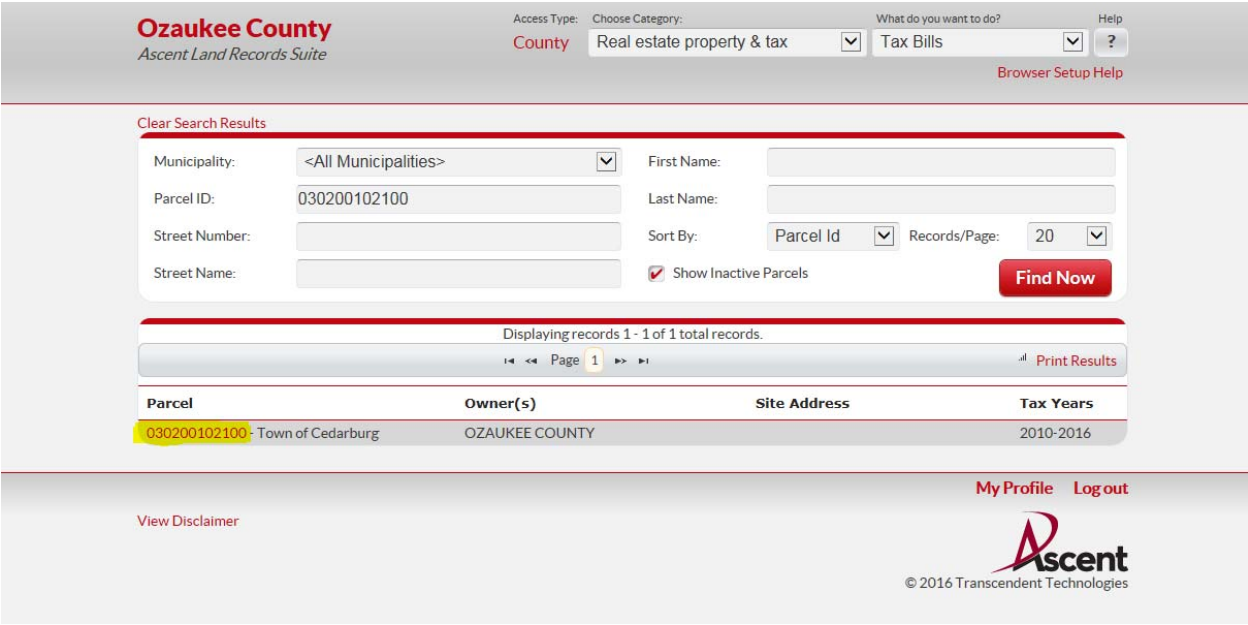
Search by Parcel ID (no dashes or dots) **or** Street Number and Street Name (name only-example 100 South Main Street- only enter **Main** on Street Name field). You will not need a log in or to create a profile.

First Name and Last Name fields are grayed out and are only used internally by Ozaukee County.

Click on the red “Find Now” button. This will display your information below the search fields.



Click the red parcel number on the left side of the screen to open a new screen with the details of your parcel.



Under "Select Detail", click on the drop down arrow and choose TAXES.
