

CHAPTER III

TRAFFIC RULES & REGULATIONS FOR OZAUKEE COUNTY

3.01 OZAUKEE COUNTY TRAFFIC CODE

3.011 (1) Except as otherwise specifically provided in this code, the statutory provisions in Chapters 340 to 348 of the Wisconsin Statutes, describing and defining regulations with respect to vehicles and traffic, exclusive of any provisions therein relating to penalties to be imposed and exclusive of any regulations for which the statutory penalty is a fine or term of imprisonment, are hereby adopted and by reference made a part of this code as if fully set forth herein. Any act required to be performed or prohibited by any statute incorporated herein by reference is required or prohibited by this code. Any future amendments, revisions or modifications of the statutes incorporated herein are intended to be made part of this code in order to secure uniform statewide regulation of traffic on the highways, streets and alleys of the State of Wisconsin.

3.012 Disorderly Conduct With A Motor Vehicle.

(1) Whoever does any of the following may be ordered to forfeit as hereinafter provided:

(a) Upon any street or highway, public or private property, makes or causes to be made any unreasonable noise, which disturbs or tends to disturb the peace and quiet of any person in the vicinity thereof by squealing tires of his/her motor vehicle, or by causing loud and unnecessary acceleration of such motor vehicle.

(b) Operates a motor vehicle in such a manner as to cause dirt, stones, rubber or other debris to be thrown by the wheels of such motor vehicle upon the person or property of another or to be thrown in a manner creating or tending to create an unreasonable risk or hazard to others upon the roadway or adjoining pedestrian walkway.

3.013 Penalties

(1) Any person who shall violate any of the provisions of this traffic code shall upon conviction thereof forfeit an amount as set forth in the Uniform Traffic Deposit Schedule adopted by the Wisconsin Judicial Conference, as that deposit schedule may from time to time be amended, revised or modified with such revisions or modifications incorporated into this ordinance by reference, plus costs of prosecution, unless a different forfeiture amount for a violation is set forth specifically in this code's forfeiture and deposit schedule and in default of payment of the forfeiture and costs of prosecution shall be imprisoned in the county jail until said forfeiture and costs are paid, but not exceeding 90 days.

(2) The provision of Section 345.16 of the Wisconsin Statutes providing for compulsory Safety School attendance shall apply to adjudications of violation of any provisions of said Ozaukee County Traffic Code.

3.014 Repeal of Conflicting Ordinances. All Ordinances regulating traffic upon the streets and highways of the County of Ozaukee, State of Wisconsin, and all Ordinances or parts of Ordinances in conflict with this Ordinance, heretofore enacted by the County Board of Supervisors of Ozaukee County, Wisconsin are hereby repealed.

3.015 Severability.

(1) The provisions of this Ordinance shall be deemed severable and it is expressly declared that the County Board of Supervisors would have passed the other provisions of this Ordinance irrespective of whether or not one or more provisions may be declared invalid and if any provision of this Ordinance or the application thereof to any person or circumstances is held invalid, the remainder of the Ordinance and the application of such provisions to other persons or circumstances shall not be affected thereby.

3.02 SPEED LIMITS. The maximum permissible speed at which vehicles may be operated.

(1) County Trunk Highway "O", Towns of Grafton and Saukville.

(a) Twenty-five (25) miles per hour from its intersection with State Trunk Highway 60, northerly to Northbrooke Drive

(b) Thirty-five (35) miles per hour from its intersection with Northbrooke Drive, northerly to Cedar Creek Road.

(c) Forty-five (45) miles per hour from its intersection with Cedar Creek Road, northerly to the corporate limits of the Village of Saukville.

(d) Twenty-five (25) miles per hour from the north corporate limits of the Village of Saukville northerly to a point 450 feet south of Cold Springs Road.

(e) Thirty-five (35) miles per hour from a point 450 feet south of Cold Springs Road to a point 1,000 feet north of Cold Springs Road.

(f) Forty-five (45) miles per hour from a point 1,000 feet north of Cold Springs Road northerly and westerly to the junction with County Trunk Highway "I".

- (2) County Trunk Highway "A"
 - (a) Town of Belgium
 - 1. Thirty-five (35) miles per hour from a point 0.2 of a mile west of its west junction with County Trunk Highway "B" in the unincorporated place known as Holy Cross, easterly for a distance of 0.8 of a mile.
 - (b) Unincorporated Village of Waubeka (Town of Fredonia)
 - 1. Forty-five (45) miles per hour from its intersection with County Trunk Highway "Y", easterly to its intersection with County Trunk Highway "H".
- (3) County Trunk Highway "Z"
 - (a) Unincorporated Village of Waubeka (Town of Fredonia)
 - 1. Thirty (30) miles per hour from its north intersection with County Trunk Highway "H", easterly for a distance of 0.2 of a mile.
 - 2. Forty-five (45) miles per hour from a point 0.2 of a mile east of its intersection with CTH H, easterly to its intersection with CTH I. (09-5)
- (4) County Trunk Highway "D"
 - (a) Town of Belgium
 - 1. Twenty-five (25) miles per hour from a point 0.65 of a mile east of its intersection with C.T.H. "LL", easterly for a distance of 0.40 of a mile.
 - 2. Thirty-five (35) miles per hour from a point 0.65 of a mile east of its intersection with C.T.H. "LL", westerly to the east corporate limits of the Village of Belgium.
 - (b) Village of Belgium
 - 1. Twenty-five (25) miles per hour from the west line of Lilac Lane to the southbound on ramp for I-43.
 - 2. Thirty-five (35) miles per hour from the southbound on ramp for I-43 to the easterly corporate limits of the Village of Belgium.
- (5) County Trunk Highway "C"
 - (a) Town of Cedarburg
 - 1. Thirty-five (35) miles per hour from the east corporate limits of the City of Cedarburg easterly to the intersection of Green Bay Road.
 - 2. Forty-five (45) miles per hour from the west corporate limits of the City of Cedarburg, westerly to the west county line.

3. Forty-five (45) miles per hour from the intersection of Green Bay Road easterly to the east line of the Town of Cedarburg.
- (b) Town of Port Washington
 1. Forty (40) miles per hour from the south corporate limits of the City of Port Washington southerly for a distance of 0.84 of a mile.
 2. Forty-five (45) miles per hour from a point 0.84 of a mile south of the corporate limits of the City of Port Washington southerly to the south line of the Town of Port Washington.
- (c) Town of Grafton
 1. Forty-five (45) miles per hour from the north line of the Town of Grafton southwesterly and southerly to the south line of the Town of Grafton and westerly on the south line of Section 32 to the east line of the Town of Cedarburg.
- (6) County Trunk Highway "K", Dacada (Town of Belgium)
 - (a) Thirty (30) miles per hour from its intersection with County Trunk Highway "B", westerly for a distance of 0.63 of a mile.
- (7) County Trunk Highway "CC" (Town of Port Washington)
 - (a) Thirty-five (35) miles per hour from its intersection with State Trunk Highway 32, easterly for a distance of 0.79 of a mile.
- (8) County Trunk Highway "T"
 - (a) Town of Cedarburg
 1. Forty-five (45) miles per hour from a point 0.70 of a mile east of its intersection with County Trunk Highway "Y", easterly to its intersection with State Trunk Highway 181.
 2. Thirty-five (35) miles per hour from its intersection with State Trunk Highway 181, easterly to the west corporate limits of the City of Cedarburg.
 3. Forty-five (45) miles per hour from the east corporate limits of the City of Cedarburg easterly to the west limits of the Town of Grafton.
 - (b) Town of Grafton
 1. Forty-five (45) miles per hour from the west limits of the Town of Grafton easterly to its intersection with Green Bay Road.

- (9) County Trunk Highway "KW"
 - (a) Village of Belgium
 - 1. Thirty-five (35) miles per hour from Iyla Avenue to a point 4500 feet north of CTH "D". (07-1)
 - 2. Twenty-five (25) miles per hour from Iyla Avenue to a point 1350 feet south of CTH "D".
 - 3. Thirty-five (35) miles per hour, beginning at a point 1350 feet south of CTH "D" to a point 2650 feet southerly thereof.
 - (b) Town of Port Washington
 - 1. Forty-five (45) miles per hour from the intersection of Lake Drive southerly to the intersection with County Trunk Highway "H".
- (10) County Trunk Highway "NN" (Town of Cedarburg)
 - (a) Forty-five (45) miles per hour from Cedar Creek Road westerly to a point 0.28 of a mile west of Horns Corners Road.
- (11) County Trunk Highway "LL"
 - (a) Village of Belgium
 - 1. Thirty-five (35) miles per hour from a point 2700 feet north of CTH "D" to a point 4500 feet south of CTH "D". (07-1)
 - (b) Town of Port Washington
 - 1. Thirty-five (35) miles per hour from a point starting 0.46 of a mile north of the intersection of S.T.H. 32 south to a point 0.13 of a mile south of the intersection of S.T.H. 32.
 - 2. Fifty-five (55) miles per hour from a point 0.13 south of the intersection of S.T.H. 32, south to S.T.H. 33.
 - 3. Forty-five (45) miles per hour from S.T.H. 33 south to the intersection with S.T.H. 32.
- (12) County Trunk Highway "KK"
 - (a) Town of Port Washington
 - 1. Thirty-five (35) miles per hour from the Port Washington city limits to a point 1300 feet northwesterly of the city limits.
 - 2. Forty-five (45) miles per hour from a point 1300 feet northwesterly of the Port Washington city limits to a point 0.2 miles northwest of County Trunk Highway "LL".

1. Thirty-five (35) miles per hour from Interstate Highway 43 northerly for a distance of 0.36 of a mile.

1. Forty-five (45) miles per hour from a point 1,000 feet north of the intersection of CTH "I" and STH 33 to a point 1,000 feet south of the intersection of CTH "I" and STH 33.
- (c) Town of Fredonia
1. Forty-five (45) miles per hour from the intersection with CTH Z to a point 300 feet north of the intersection with Fredonia Kohler Road. (09-5)
- (15) County Trunk Highway "W"
- (a) Town of Grafton
1. Forty-five (45) miles per hour from County Trunk Highway "C", northerly 2.28 miles to the south corporate limits of the Village of Grafton.
 2. Forty-five (45) miles per hour from a point 0.25 miles north of State Trunk Highway 60, at the north corporate limits of the Village of Grafton, thence northerly 3.40 miles to E. Sauk Road.

- (e) City of Mequon
 1. Thirty-five (35) miles per hour from the south line of Ozaukee County at County Line Road, northerly 3.05 miles to Glen Oaks Lane.
 2. Forty-five (45) miles per hour from Glen Oaks Road northerly 3.06 miles to County Trunk Highway "C".
- (16) County Trunk Highway "V"
 - (a) Twenty-five (25) miles per hour from its intersection with State Trunk Highway 60, northerly to Willow Lane.
 - (b) Forty-five (45) miles per hour from its intersection with Willow Lane, northerly to Cheyenne Avenue.
- (17) County Trunk Highway "Y" (05-16)
 - (a) Twenty-five (25) miles per hour from a point 1200 feet southerly from its intersection with State Trunk Highway 33, to a point 2100 feet northerly from its intersection with State Trunk Highway 33.

3.03 OZAUKEE COUNTY SNOWMOBILE CODE.

3.031 State Snowmobile Laws Adopted.

(1) The statutory provisions describing and defining regulations with respect to snowmobiles in the following enumerated sections of the Wisconsin Statutes, exclusive of any provisions therein relating to the penalties to be imposed or the punishment for violation of the Statutes, are hereby adopted and by reference made a part of this Ordinance as if fully set forth herein. Any act required to be performed or prohibited by any statute incorporated herein by reference is required or prohibited by this Ordinance.

(a) Chapter 350 or Sections 346.04, 346.05, 346.11, 346.14 (1), 346.18, 346.19, 346.20, 346.21, 346.26, 346.27, 346.33, 346.35, 346.37, 346.39, 346.40, 346.44, 346.46, 346.47, 346.48, 346.50 (1)(b), 346.51, 346.52, 346.53, 346.54, 346.55, 346.87, 346.88, 346.89, 346.90, 346.91, 346.92 (1) and 346.94 (1), (6), (6m) and (9), Wisconsin Statutes.

3.033 Penalties.

(1) Any person who shall violate any of the provisions of this section shall upon conviction forfeit as set forth under the Uniform State Traffic Deposit Schedule prepared by the Wisconsin Judicial Conference as from time to time may be modified, revised or amended, with such modifications, revisions or amendments incorporated into this ordinance by reference, plus the costs of prosecution, and in default of payment of the forfeiture and costs of prosecution shall be imprisoned in the county jail until said forfeiture and costs are paid, for a period not exceeding 90 days; unless a different forfeiture amount for a violation is set forth by this code in the forfeiture deposit schedule contained herein and then that forfeiture shall apply.

3.034 Severability.

(1) The provisions of this Ordinance shall be deemed severable and it is expressly declared that the County Board of Supervisors would have passed the other provisions of this Ordinance irrespective of whether or not one or more provisions may be declared invalid and if any provision of this Ordinance or the application thereof to any person or circumstances is held invalid, the remainder of the Ordinance and the application of such provisions to other persons or circumstances shall not be affected thereby.

3.04 DISPOSAL OF ABANDONED MOTOR VEHICLES

Ozaukee County, under the authority granted by Section 342.40 (3) of the Wisconsin Statutes:

(04-20)

- (1) **VEHICLE ABANDONMENT PROHIBITED.** No person shall leave unattended any motor vehicle, as defined in Section 342.40 (1m) of the Wisconsin Statutes, on any public highway or private or public property, for such time and under such circumstances as to cause the vehicle to reasonably appear to have been abandoned. Whenever any vehicle has been left unattended without the permission of the property owner for more than forty-eight (48) hours the vehicle is deemed abandoned and constitutes a public nuisance.
- (2) **IMPOUNDING.** Any vehicle in violation of this Ordinance shall be impounded as provided for in Section 342.40 (2) of the Wisconsin Statutes until lawfully claimed or disposed of as provided for in Section 342.40 (2) of the Wisconsin Statutes.
- (3) **DISPOSAL.** Any abandoned vehicle shall be disposed of as provided in Section 342.40 (3) of the Wisconsin Statutes.
- (4) **STORAGE FEES.** The purchaser shall pay the storage fees, as provided in Section 342.40 (3) of the Wisconsin Statutes, shall be at a rate as provided for in Section 2.26 (2)(e) of the Code of Ordinances.

3.05 INTOXICANTS IN MOTOR VEHICLES

- (1) No person may drink fermented malt beverages or intoxicating liquor in any motor vehicle when the vehicle is upon a highway.
- (2) No person may possess on his or her person, in a privately owned motor vehicle upon a public highway, any bottle or receptacle containing fermented malt beverages or intoxicating liquor if the bottle or receptacle has been opened, the seal has been broken or the contents of the bottle or receptacle have been partially removed.
- (3) The owner of a privately owned motor vehicle, or the driver of the vehicle if the owner is not present in the vehicle, shall not keep, or allow to be kept in the motor vehicle when it is upon a highway any bottle or receptacle containing fermented malt beverages or intoxicating liquor if the bottle or receptacle has been opened, the seal has been broken or the contents of the bottle or receptacle have been partially removed. This subsection does not apply if the bottle or receptacle is kept in the trunk of the vehicle or, if the vehicle has no trunk, in some other area of the vehicle not normally occupied by the driver or passengers. A utility compartment or glove compartment is considered to be within the area normally occupied by the driver and passengers.
- (4) This section does not apply to a motor bus as defined in Section 340.01 (31), Wisconsin Statutes.
- (5) Definitions: (Sections referred to herein are found in the Wisconsin Statutes.)
 - (a) "Fermented malt beverages" has the meaning designated in Section 125.02(6).
 - (b) "Intoxicating liquor" has the meaning designated in Section 125.02 (8).

(c) "Highway" has the meaning designated in Section 340.01 (22).

(6) Any person violating this section shall be required to forfeit, upon conviction, not more than \$100.00 together with the costs of prosecution, and upon default of payment of said forfeiture, said person shall be imprisoned in the county jail until said forfeiture and costs are paid, but not exceeding 90 days.

3.06 PARKING REGULATIONS

(1) Except temporarily for the purpose of and while actually engaged in loading or unloading or in receiving or discharging passengers or property and while the vehicle is attended by a licensed operator so that it may be moved promptly in case of an emergency or to avoid obstruction of traffic, no person shall at any time park or leave standing any vehicle, upon any of the following highways or parts of highways:

(a) On the north side of CTH "D" from Sauk Trail Road east to Lake Michigan (Town of Belgium).

(b) On the northwest side of County Trunk Highway "NN", from the intersection of County Trunk Highway "Y" to the intersection of Pleasant Valley Road (Town of Cedarburg).

(c) On the south side of CTH "D" from Homestead Drive east to Lake Michigan, between the hours of 11:00 P.M. and 5:00 A.M. (Town of Belgium.)

(d) On the north side of CTH "D" from a point 400 feet east of Lake Church Road to the intersection with Lake Church Road. (Town of Belgium.)

(e) On the north side and the south side of CTH "C" from Washington Avenue to the intersection with STH 181. (Town of Cedarburg and City of Cedarburg).

(f) On the east side of CTH "I", beginning at a point 280 feet north of Cedar Creek Road to a point 340 feet northerly thereof. (03-6)

(g) On the access drive and fire lane, beginning at a point on CTH "I", said point being 812 feet north Cedar Creek Road, thence easterly 100 feet and southerly 360 feet. (03-6)

(h) On the east side of CTH "O", beginning at a point 1,060 feet north of the intersection of Cedar Sauk Road, to a point 1,660 feet northerly thereof. (03-9)

(i) On the west side of CTH "O", beginning at a point 1,260 feet north of the intersection of Cedar Sauk Road, to a point 1,660 feet northerly thereof. (03-9)

(j) On both sides of CTH "O", from Center Road to Deerfield Drive (Town of Saukville).

(k) On both sides of CTH "I", beginning at a point 200 feet north of River Park Road, to a point 800 feet south of River Park Road. (07-7)

(l) On both sides of CTH "I", beginning at a point 450 feet north of Fredonia-Kohler Road, south to CTH "Z". (07-7)

Parking Regulations 3.06

- (2) Vehicles parking in the parking area on the south side of CTH “D” at Lake Michigan shall park within the designated and marked stalls.
- (3) Minimum and maximum forfeitures for violation of nonmoving traffic violations adopted by reference in Section 3.011 of this Code, as described in Wisconsin Statutes, Chapters 341 to 348, shall be as provided for the comparable state nonmoving traffic violation.
- (4) The penalty for all other parking violations not included under paragraph (2) above shall be a forfeiture of not less than \$5.00 nor more than \$40.00.

3.07 OZAUKEE COUNTY ALL-TERRAIN VEHICLE CODE

3.071 State All-Terrain Vehicle Laws Adopted.

(1) The statutory provisions describing and defining regulations with respect to all-terrain vehicles in Section 23.33 of the Wisconsin Statutes, exclusive of any provisions therein relating to the penalties to be imposed or the punishment for violation of the statutes, are hereby adopted and by reference made a part of this Ordinance as if fully set forth herein. Any act required to be performed or prohibited by any statute incorporated herein by reference is required or prohibited by this Ordinance. Any further amendments, revisions or modifications of the statutes incorporated herein are intended to be made part of this code in order to secure uniform statewide regulation of all-terrain vehicles.

3.072 Penalties.

(1) Any person who shall violate any of the provisions of this Ozaukee County All-Terrain Vehicle Code shall upon conviction thereof forfeit not less than \$10.00 nor more than \$250.00, together with the costs of prosecution and in default of payment of the forfeiture and costs of prosecution shall be imprisoned in the county jail until said forfeiture and costs are paid but not exceeding 90 days.

3.073 Severability.

(1) The provisions of this Ordinance shall be deemed severable and it is expressly declared that the County Board of Supervisors would have passed the other provisions of this Ordinance irrespective of whether or not one or more provisions may be declared invalid and if any provision of this Ordinance or the application thereof to any person or circumstances is held invalid, the remainder of the Ordinance and the application of such provisions to other persons or circumstances shall not be affected thereby.

3.08 PARK AND RIDE LOTS PARKING

(1) It shall be unlawful for either the owner or driver of a vehicle, except for emergencies, or with approval of the Ozaukee County Sheriff’s Department, to leave a detached trailer at any time at the park and ride lots located at:

- (a) State Trunk Highway 32 and County Trunk Highway “LL”.
- (b) County Trunk Hwy “W” and County Trunk Highway “V”.

3.08 Park and Ride Lots

- (c) State Trunk Highway 57 and County Trunk Highway “H”.
- (d) Interstate Highway 43 and County Trunk Highway “C”.
- (2) For purposes of this ordinance “trailer” means a vehicle without motive power designed for carrying property or passengers wholly on its own structure and for being drawn by a motor vehicle, but does not include a mobile home.
- (3) Violation of this ordinance is punishable by a forfeiture of \$200.00 plus costs, fees and disbursements.
