The implementation will be rather complex, and because Wisconsin has its own GI Bill for education, I expect that there will be many long meetings with State Legislators and representatives for the UW System and the various veterans organization, so we can work out a

compromise package that continues the Wisconsin tradition of honoring the service of our military and giving our veterans the best possible educational opportunities we can.

Book Allowance

Housing allowance

## VA MEDICAL SYSTEM NEWS

The VA Medical System remains open to many veterans. That's the "good" news.

We here in Wisconsin are fairing better than a number of other areas in the country.

As of this writing, there is only about a 3-5 month waiting list at the VAMC Milwaukee, or its branch clinic in Cleveland, WI.

Please remember, that if you do not have a service-connected disability, then you must meet the "Means Test" requirements to get enrolled in the system. Current Means

Test levels for a resident of Ozaukee County are:

Single Veteran \$37,650

Married Veteran (no Children) \$43,000

The "cap" increases by about \$5,000 for each dependent child.

There is a "rumor" that there will be some additional monies in the system for next year, and that these "caps" may increase some. I will keep my eyes and ears open, and keep you informed.

## VA Enhanced Mortgage Options

The Federal VA has made some changes to their Home Loan Guarantee Program.

In response to the current down-turn in the housing industry, and the meltdown in the mortgage arena, the VA is offering to refinance loans made to veterans from conventional or sub-prime lenders.

The VA will refinance the veterans loan for up to 100% of the appraised value of their home.

This will allow veterans to get out from under some of these “exotic” and harmful adjustable rate mortgages, and get into a stable fixed mortgage with VA.

The VA, both state and federal, has never participated in the sub-prime lending arena. Consequently the default rate for federal and state VA home loans has remained well below the industry average.

The WDVA default rate is below 1% and is the envy of most lending institutions.

There are certain exceptions given for the extremely low income, former POWs, and those who’s VA doctor specifically recommends receive these areas of care.

Otherwise, don’t bet the farm on getting help in these areas!
