Discussion on texting while driving will be illegal. Lt. McCormick- enforcement will be problematic.

Click it or Ticket enforcement program started in Ozaukee County-\$12,000.00 grant. Operating While Intoxicated enforcement program from now to 09.30.10 with extra patrol for St. Patrick's Day.

Chief Graff advised that his department now has two drug recognition specialists with the department sending another officer for training. State Patrol has two (2) in this region. Sheboygan County Sheriff's Department also has two (2) deputies available.

Bob Dreblow-roundabouts possibilities of having problems with maintenance of them.

Summer 2010-Reconstruction in spring-Cedar Sauk and Cedar Creek roads, bicycle path to be placed.

CTH W project starts in 03.2010 from Mequon Road to Glen Oaks. Signals to be placed at Glen Oaks and Eastbrook (four lane divided highway); Metro Market will be constructed there.
