BACKGROUND INFORMATION, DESCRIBE MEASURABLE IMPACT ON SERVICES:

**POSITION ALTERNATIVE ANALYSIS:** This request was initially part of our 2020 Budget. However, the current part-time Deputy Clerk IV has resigned from this position effective 6/10/2019. Therefore, the department needs to begin the search for a qualified Deputy Clerk IV and if an internal promotion occurs, effectuate the replacement process for the Deputy Clerk III. We are requesting the two part time positions return to their former status of a full time position of Deputy Clerk IV. These two part time positions were once a full time position assigned to Branch 2. The position was split into two part time positions to accommodate the current Branch 2 judge to have a staff he felt comfortable working with and were willing and available. The newly elected judge has expressed a desire for a full time staff to accommodate his court and this department supports having fulltime Deputy Clerk IV's assigned to all branches. Part time positions are not desirable or effective for a Deputy Clerk IV as there are too many justice partners requiring access to the branch throughout the entire week for scheduling, hearings and other necessary contact.

- 1) Do Nothing: **Not desirable.**
- 2) Contract out the service: **Not available.**
- 3) Increase hours of existing employees, hire part-time, lower classification, shared position, etc: **Not an available option, as we are short staff of Deputy Clerk III's. There will be some temporary overtime to cover the court's needs but I am concerned of employee burn out if extended for more than a few months.**
- 4) Filling vacant position as is: **Will not meet the current or future needs of the court.**
