The County Board reconvened at 9:13 AM pursuant to adjournment and was called to order by Chairperson Schlenvogt.

The Clerk took the roll. All members were present except: Excused - Supervisors: Winker, Henrichs and Rothstein.

Board members and guests stood and recited the Pledge of Allegiance to the Flag.

Motion made by Supervisor Nelson, seconded by Supervisor Wirth, that the May 1 and May 15, 2019 minutes be approved as submitted. A voice vote was taken. Motion carried.

Under public comment, Chairperson Schlenvogt announced the Flag Day Celebration on June 9 in Waubeka and Supervisor Wolf noted the newspaper article ranking Ozaukee County as the 10th Happiest Place to live in the U.S. for the second year in a row.

A moment of silence was observed for the victims of a mass shooting at the Virginia Beach Public Works building.

Under communications, Corporation Counsel Gorden explained the circulation of a request pursuant to Wis. Statutes Sec. 59.11(2)(a) to call a special meeting of the County Board on June 26 and July 10, 2019 to be held at Columbia St. Mary's Center at the Fairgrounds at 9:00 AM for the purpose of a Strategic Planning session.

There were no claims.

County Administrator Dzwinel presented his monthly report that included information on the Lasata Senior Living Campus census and engaging a consultant for a study on a Community Based Residential Facility as part of the continuum of care at the campus; hiring of a joint Washington/Ozaukee Transit Superintendent; 2020 Budget planning; today's agenda items and update on security for the Administration Center.
