Metal cleaners, solvent-based  
Mineral spirits  
Nail polish removers  
Oil- and chemical-based paints (NOT LATEX)  
Oven cleaners\*\*  
Oxidine  
Paints (e.g., lead enamel-based, oil-based, metal-based) (NOT LATEX)  
Paint removers  
Paint thinners/strippers  
Parts cleaners  
Pesticides (including cancelled/banned pesticides)  
Photography chemicals  
Polish removers\*\*  
Polish with solvents\*\*\*  
Pool/spa chemicals with bleaches\*  
Rat/rodent poisons  
Shellacs  
Shoe polishes  
Sodium nitrates  
Solvents (e.g., ketone, acetone, turpentine, mineral spirits, dry cleaning)\*\*\*  
Spot removers  
Stains (e.g., lead enamel-based, oil-based, metal-based) (NOT LATEX)\*\*

\* Never mix products containing ammonia with those containing bleach.  
\*\* Some but not all of these products will be accepted; read labels.  
\*\*\* Solvent products contain words such as "flammable," "combustible," and "petroleum distillates" on the label.  
\*\*\*\* Farm chemicals in all forms and container sizes (e.g., drums, wooden casks, bottles, five-gallon metal, plastic, pressurized cylinders, canisters).

NOTE: Petroleum and petroleum by-products are considered hazardous waste and must be disposed of properly.
