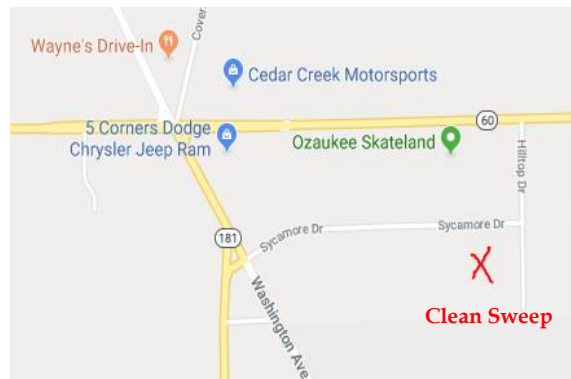

The Ozaukee County Clean Sweep hazardous waste collection is for all Ozaukee County residents **EXCEPT THE CITY OF PORT WASHINGTON**. City of Port Washington residents may take household hazardous waste to the Veolia location at 1275 Mineral Springs Drive any Monday . . . free of charge. **BUT**, tires and electronics/appliances will be accepted at Clean Sweep.

## **WE WILL NOT ACCEPT:**

1. LATEX PAINTS OR LATEX STAINS
2. MEDICATIONS (RX OR OTC)
3. Ammunition/ordnance
4. Compressed gas cylinders
5. Explosives, including detonators and blasting caps
6. High-pressure cylinders/tanks, propane tanks, fire extinguishers
7. Infectious or biological wastes or needles (sharps)
8. Motor oil (used)
9. Radioactive chemicals and devices (e.g., smoke alarms)

**We WILL accept most unlabeled  
(origin unknown) chemicals.**
