COMMENDATION - JENNIFER K. ROTHSTEIN

WHEREAS, Jennifer K. Rothstein has served the citizens of Ozaukee County with dedication, distinction and honor, while serving on the Ozaukee County Board of Supervisors for fourteen years; and

WHEREAS, Ms. Rothstein began her service to the Ozaukee County Board on Tuesday, April 18, 2006, and has provided devoted service for her district in the Village of Bayside, City of Mequon, and all of Ozaukee County; and

WHEREAS, Ms. Rothstein’s professional background in environment and education make her contributions to Ozaukee County ones that will stand the test of time; and

WHEREAS, during her tenure on the County Board, Ms. Rothstein was a zealous advocate for land preservation, a fervent supporter of the county park system and a long-tenured Chairperson of the Natural Resources Committee. Her work led to the following important county efforts:

- The development of the Little Menomonee Natural Area in the City of Mequon, its restoration of the waterway and acceptance of the parcel into the county park system.
- The bolstering and ongoing effort to preserve the Lake Michigan shoreline and Cedar Gorge in the Town of Grafton.
- Providing a voice for county efforts to conserve energy and water usage in the creation of the Energy Action Commission.
