

RESOLUTION NO. 21-54

OZAUKEE COUNTY LAND INFORMATION PLAN 2022-2024

WHEREAS, Wisconsin established a Land Records Modernization Program in 1989; and

WHEREAS, a county that established a Land Information Office and adopted a State-approved Land Records Modernization Plan was able to participate in the Land Records Modernization Program; and

WHEREAS, Ozaukee County established a Land Information Office in 1989, adopted a State-approved Land Records Modernization Plan in 1992, updated the plan in 1996, 2005, 2011, 2017 and 2019, and has continuously participated in the Land Records Modernization Program; and

WHEREAS, the Land Records Modernization Program is now called the Land Information Program and the Land Records Modernization Plan is now called the Land Information Plan; and

WHEREAS, a Land Information Plan is required for Ozaukee County to continue its participation in the Land Information Program, and obtain compliance with Wis. Stat. 16.967 in order to obtain record modernization funding, and

WHEREAS, the 2013 state budget bill known as Act 20 now requires counties to update and submit their Land Information Plans to the Wisconsin Department of Administration every three years after being approved by the County's Natural Resources Committee; and

WHEREAS, the Ozaukee County Natural Resources Committee accepted and approved the Ozaukee County Land Information Plan 2022-2024 on December 2, 2021; and

NOW, THEREFORE, BE IT RESOLVED that the Ozaukee County Board of Supervisors hereby accepts and approves the Ozaukee County Land Information Plan for 2022-2024.
