AMENDING SECTION 2.24 (2) OF THE OZAUKEE COUNTY CODE OF ORDINANCES  
PERTAINING TO FEES FOR COPIES AND SERVICES

An Ordinance amending Section 2.24 (2) of the Ozaukee County Code of Ordinances pertaining to Fees for Copies and Services.

The County Board of Supervisors of the County of Ozaukee does ordain that Section 2.24 (2) of the Ozaukee County Code of Ordinances be amended as follows:

2.24 FEES FOR COPIES AND SERVICES

- (2) Fees for services are established as follows:
  - (a) Signing of Death Certificates - ~~\$100.00~~ \$106
  - (b) Use of the county morgue by other counties for autopsies or similar procedures \$500.00 per day.
  - (c) Storage of bodies in the county morgue by other counties and all funeral directors - \$50.00 per day.
  - (f) Issuance of Cremation Permits - ~~\$200.00~~ \$213
  - (g) Issuance of Disinterment Permits - \$75.00
  - (h) Body Bag - \$100
  - (i) Body Transport - \$159

This Ordinance shall take effect upon enactment and publication.
